#### **ETHICS REPAIR LIST**

#### **PREREQUISITES**

1. A complete Scientology Drug Rundown.

2. A C/S 53RL done to F/Ning list. (Done per HCOB 30 Oct 78', C/S SERIES 53, USE OF.)

WITHOUT THE ABOVE 2 SETUP STEPS FULLY DONE, THIS REPAIR LIST WILL FAIL!

#### **TRIPLE VS. QUAD FLOWS**

Determine whether the PC is a Triple or Quad Flow PC before starting this list, as you must not start running Flow 0 on a Triple Flow PC.

DO NOT RUN <u>ANY</u> FLOW THAT DOES NOT READ. Check each flow for a read before running it.

#### EXTERIOR

Nothing is more likely to exteriorize a PC than this list. If the PC goes exterior during this list, do not audit past it, gently end off the session per HCOB 7 Mar. 75', *EXTERIOR AND ENDING SESSION*.

If the PC has a big win, end off with the session and let them have their win. When the PC is off the win, the list can then be resumed.

The last question on the list is there to detect exteriorization. If the PC went exterior on this action, and they have not yet had an interiorization rundown, their Interiorization/Exteriorization must be checked, and if reading, fully handled *before* starting any other auditing action per HCOB 4 Oct. 78', *INTERIORIZATION HANDLING SIMPLIFIED*.

In all cases the Ethics Repair List is completed through to the end of the list.

#### **INSTRUCTIONS**

This list is assessed and handled by Method 3 assessment only.

All questions that read are taken to F/N via two way comm. or earlier similar to F/N unless otherwise noted. On some questions, an additional handling is indicated after the question. Withholds and overts are handled with standard rudiment procedure, per HCOB 11 Aug 78 I, *RUDIMENTS, DEFINITION AND PATTER and HCOB 14 Mar. 71 'R rev. 25 July 73', F/N EVERYTHING.* 

**Preliminary Step 1**: At session start, check 3 Rudiments to F/N.

**Preliminary Step 2**: R-Factor the PC - "We are going to do the Ethics Repair List. I am here to help you There isn't anything so bad that it can't be undone, or forgiven. Is there any reason not to begin?"
